Cobalt Blue Announces \$2.4m Research and Development Tax Incentive Rebate

Cobalt Blue Holdings Limited (Cobalt Blue) recently released an <u>Investor Presentation (18 November 2024)</u> in which the Company advised it expected to receive a 2024 Research and Development (R&D) tax Rebate.

The Company is pleased to announce that on 11 December, it received its 2024 R&D Tax Incentive Rebate of approximately A\$2.4 m from the Australian Tax Office.

The rebate relates to an approximate A\$5.5m investment at the Broken Hill Technology Development Centre. Activities included evaluating and optimising key unit operations and prepare supporting information for the detailed engineering of the proposed Kwinana Cobalt Refinery (KCR).

Throughout this year, the Technology Development Centre's primary focus was testing third-party feedstock to produce battery-grade cobalt sulphate and nickel byproducts. This work has provided vital data and information to advance the project through the next stages of pre-development and ultimately to a Financial Investment Decision.

Additionally, the technology and processes developed at the Broken Hill Technology Development Centre aim to be applied to extract critical minerals from mine waste. The Cobalt Blue process also removes acid-forming sulphides to commercialise sulphur production, reduce ongoing tailings management costs, and mitigate potential environmental harm.
